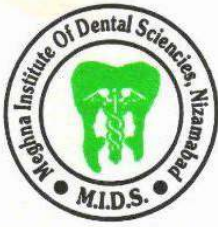
The rules framed by university grants commission (UGC) are notified in its website [www.ugc.ac.in](http://www.ugc.ac.in) that are followed for deciding the eligibility and admission for international students to dental courses (BDS, MDS).

Meghna institute of dental sciences has made a provision for admissions under foreign nationals /NRI category on fulfilling the eligibility requirements. Foreign /NRI category seats are only available for foreign nationals /candidates with NRI status.

### **Guidelines for admission of foreign/international students:**

- Should be an international student (foreign student)/Non-resident Indian(NRI).
- For foreign students, student visa is mandatory(for NRI not mandatory option).
- Students must obtain prior security clearance from ministry of home affairs and the approval of department of higher education, Ministry of Human Resource Development, Government of India, and must be on the student visa endorsed to the institution.

## Eligibility Criteria:

1. Foreign citizens, person of India origin (PIO) card holders, overseas of India (OCI), Non Resident Indian(NRI)and NRI sponsored candidates (sponsored by NRI parents or brother /sister of parents or brother /sister of candidates or grandparents of the candidates or Spouse of the candidate).The sponsor must be foreign national or holding NRI status.
2. Only those students qualified from foreign universities or boards of higher education recognised as equivalent by the association of Indian universities (AIU) are eligible for admission.

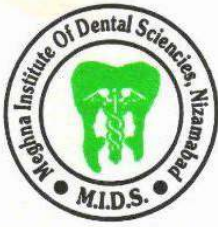
## Admissions for international students:

1. Admissions of the international students is done through the international cell of Meghna institute of dental sciences and hospital.
2. Eligible applicants need to certify that the medium of instructions for the qualifying examination passed his/her English .For applicants who have undertaken studies in a language other than English need to have a valid IELTS score. Once this is submitted, the final admission is confirmed.

## Procedure of admission:

1. The student should qualify in the NEET examination for admission in BDS and MDS courses.
2. The International student has to contact administrative wing of Meghna institute of dental sciences and hospital, Nizamabad contact number 09505445456 to get the provisional admission offer letter to obtain the student visa.
3. Submit the provisional admission letter to the Indian embassy of the respective country for obtaining student visa.

4. Submit the below mentioned documents (in original along with the attested photo copies) and get them verified by the administrative office of the college.
  - Pass certificate of the qualifying examination.
  - Marks list of the qualifying examination.
  - Student visa in original.
  - Photocopy of passport duly attested by a notary.
  - The original certificate will be returned to the students after making an endorsement.
5. Students are required to undergo medical fitness examination and get the medical fitness certificate. As per government rules all international students entering Indian on student visa must be tested for HIV and will not be given admission, if found to be positive.
6. For applicants who have taken the studies in a language other than English need to have valid IELTS score.
7. Admission of international / NRI students will be confirmed after verification of original certificates, medical fitness test and payment of required fees.
8. Even after the admission at any stage if it is noted that the qualifying degree / certificate is not recognised by AIU, the admission of the candidate is likely to get cancelled .

**NOTE :** The International students should abide all the rules of ARDCH and the code of conduct, is as applicable to the Indian student's enrolled same courses.

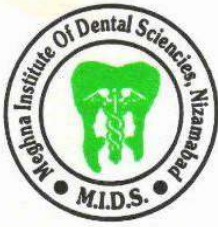
### **The responsibilities of international student's cell:**
